- 4. Prescribed TUoS Services Locational Prices the customer's contract demand is used to determine the charge.
- 5. Prescribed TUoS Services Non-Locational Prices either the capacity or energy price is applicable, depending on whether the customer load factor is above (capacity) or below (energy) the median load factor for Tasmania. Where the capacity price is applicable, the customer's contract demand is used to determine the charge. Where the energy price is applicable, historical energy is generally used to determine the charge.

Prescribed Common Transmission Service Price either the capacity or energy price is applicable, depending on whether the customer load factor is above (capacity) or below (energy) the median load factor for Tasmania.
